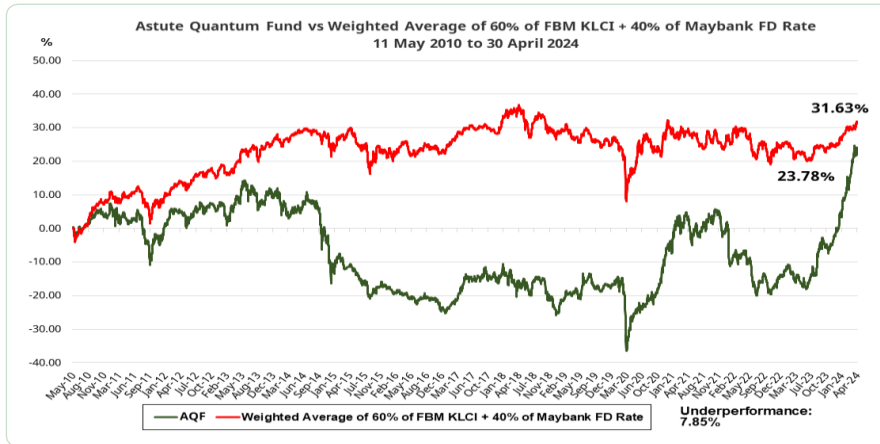


OBJECTIVE
