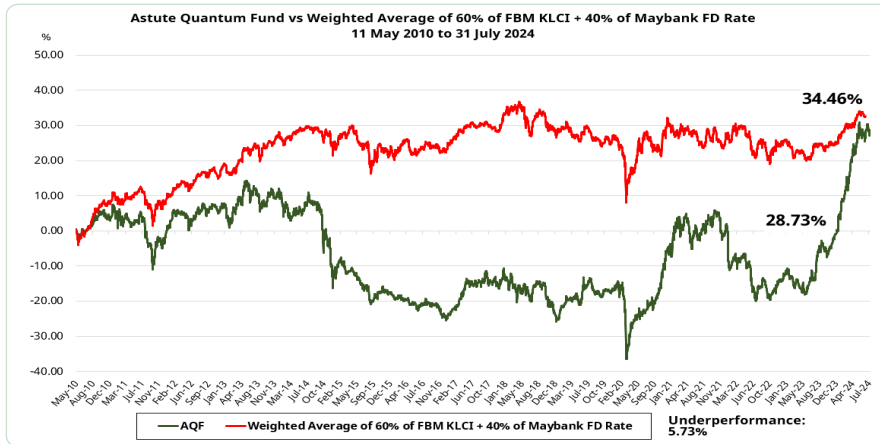


**OBJECTIVE**
