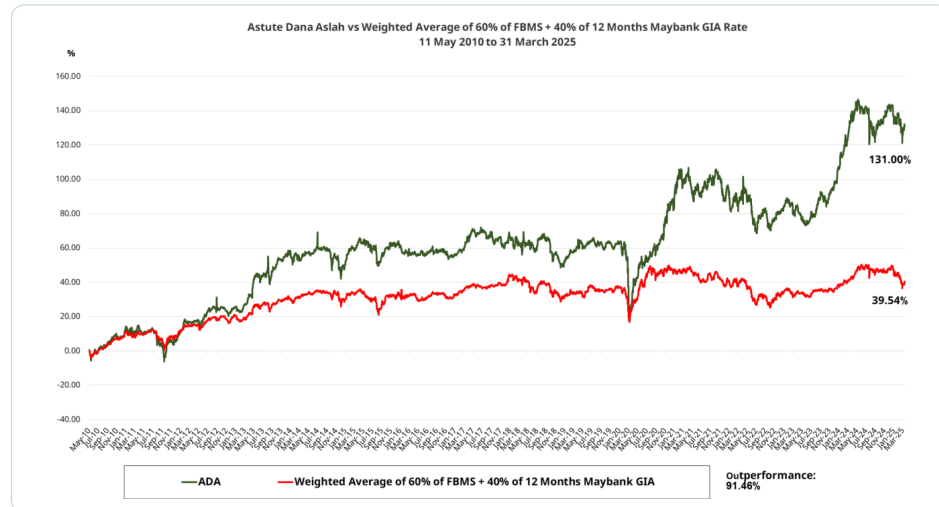


## OBJECTIVE

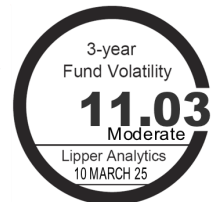
